Release of Liability and Assumption of Risk

Activity Description: Cheerleading Athletics includes but not limited to tumbling, stunting, jumping, cheerleading, dancing, conditioning and related exercises/physical activities that are conducted in a competition, camp, workshop, clinic, class or team practice setting.

(Athletes Full Name) _____ has my permission to participate in any provided activities and services of Newberg Youth Cheer, their agents, owners, members, officers, volunteers, participants, employees and all other persons or entities acting in any capacity on their behalf, including businesses sub-lessors, agencies and vendors. The avoce name athlete, as well as myself as the legal guardian, agree to abide by all rules, policies, and guidelines set forth by Newberg Youth Cheer including, but not limited to, the Newberg Youth Cheer Gym policies and Newberg Youth Cheer billing policies.

- I certify that athlete has passed a physical exam in the past eighteen months and is in good physical condition and currently under no restrictions with regard to physical activity.
- I understand that cheerleading activities always involve certain risks, including but not limited to, death, serious neck and spinal injuries resulting in complete or partial paralysis, brain damage and serious injury to virtually all bones, joints, muscles and internal organs, and that the mats and other safety equipment and apparatus provided for my protection including the active participation of a coach or teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury. The risk of harm may be mitigated to the greatest possible extent by all of the safety equipment and trained coaches, but can never be eliminated. I understand and acknowledge that athlete's o guardian;s failure to use or properly use safety equipment or may failure to follow coach's instructions increases the risk of injury or of not surviving an accident.
- I further acknowledge and understand that athlete and guardian are assuming the risk of illness or injury through athlete's participation. I assume all risks and hazards incidental to such participation including transportation to and from activities. I HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Newberg Youth Cheer, their owners, agents, members, officers, volunteers, participants, employees and all other persons or entities acting in any capacity on their behalf, WITH RESPECT TO INJURY, DISABILITY, OR DEATH, or loss or damage to person or property WHETHER ARISING FROM NEGLIGENCE OR OTHERWISE, to the fullest extent permitted by law.
- In the event of an emergency, accident or illness, I authorize Newberg Youth Cheer and its employees to administer emergency medical care to my child and/or, if deemed necessary, to secure emergency medical transport and services. Any expenses incurred as a result are my responsibility and not that of Newberg Youth Cheer. I understand that Newberg Youth Cheer employees and volunteers are not trained medical professionals and shall hold harmless Newberg Youth Cheer and its staff for any injury resulting from the rendering of temporary, immediate, or basic first aid.
- I understand that family members, friends and spectators associated with this student are required to remain in the designated viewing area while in the gym and should never be on any equipment. In regards to family, friends and spectators, I ALSO HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS Newberg youth Cheer, their owners, agents, members, officers, volunteers, participants, employEes and all other persons or entities acting in any capacity on their behalf, WITH RESPECT TO INJURY, DISABILITY, OR DEATH, or loss or damage to person or property WHETHER ARISING FROM NEGLIGENCE OR OTHERWISE, to the fullest extent permitted by law.
- I further grant permission to Newberg Youth Cheer the unrestricted right and permission to copyright, publish and use photos, videos or audio recordings of me or my athlete, made in association with my participation in Newberg Youth Cheer for any use including, but not limited to publications, art, advertisements or promotions.
